Hello Carrie:

Has been a while, hope everything is fine with you.

Carrie:

Please do not take this letter as any animosity towards you, In my work with you I have enjoyed your pleasant, professionalism in our correspondence. You would do well in the private world of business. My problem is, I am getting so frustrated and concerned with our system of excess government control over our lives.

The reason I am writing is that yesterday it rained all day here. Created puddles of water everywhere on the property. Interestingly absolutely "No" puddling of any water what so ever around the base of our waste concrete pile. The comment in the past has been that when it rains here there must be puddles at the base of the concrete waste pile, implying that we would be lying. Well there was not a single drop of any puddling of water near the concrete pile as we told you, Pam is welcome to come by the property and see for herself.

I used my meter to test for PH levels all over the property in various puddles, including the state highway ditch where water was standing. One amusing test I did was of straight rain water that had collected in a metal container. It tested PH 9, half a point above DOE limit. All the dozen spots I tested were no where near the waste concrete pile. There were two puddles about 100 feet from the waste concrete, they were at a level higher than base of concrete pile, now I assume we all know water does not flow up hill, these tested 8.5 PH. The few puddles I tested at north end of the property,

1000 feet from the crushing and concrete waste pile tested from 8.3 to as high as 9.2 PH. There was a puddle at base of waste asphalt pile that tested 8.3 PH, this is below DOE limits.

Here is an interesting fact.

I have taken (dried and cured concrete washout), tested it to be PH 12. I then have taken 100 year old freshly crushed concrete slabs and blocks, crushed into 1 ¼ inch base crushed materials for use on all private and public construction projects. Tested these new recycled crushed concrete materials, tests exactly the same as the dried cured concrete washout. "PH 12" Have even tested the wet, sludgy, slurry wash out concrete, "It also tests PH 12".

Why are we using the crushed recycle materials when we create a material that now tests PH 12 ????

Is there not a problem here ?

After crushed, tests PH 12, but is now legal to use on all public projects as per, "The New Concrete Recycle Law" ????

"NOW" I am really, really mad about this whole fiasco of the concern of PH levels being high and the idiotic rules, paper work and harassment our government is forcing on the general public. In my extensive studying on the internet and in talking with Cascade Analytical testing lab, it turns out that high or low PH numbers mean nothing per concerns of the environment. Want to let everyone know, I took a sample of our concrete dust from our concrete waste pile in for Cascade Analytical testing lab to give us the PH level of this material, it tested exactly the same as my new testing meter of which I used to test the same material. The meter is the one Pamela Perun required me to purchase. Again athletes drink PH 10 water for energy. My personal knowledge is our government lies to the people of this country in thousands of situations to intentionally create concern and paranoia of the people to then allow more arms of the government to control our lives and create worthless high cost government jobs that drain our pocket books with extra business expenses and tax's. This is exactly how the liberal Democrats want it. Reason this is fact, is that I have experimented with concrete sludge that I create by mixing dry concrete dust with water. I place the cup of sludge on shelf where the sludge will settle to the bottom with top half now clear water. Clear water will be on top of the sludge within a very short time. I purposely took a drink of this water and did not croak. The clear water will test PH 12, I guarantee you, I pour this water into a cup half and half with my well water which is a PH level of 8.5. Within one hour the half and half mix drops to PH level of 10, over night it will neutralize to PH level of 8.5, same as my well water, remember it started out at PH 12. It is interesting that one of the statements in the 2016 recycle law, states that 12 PH water seeping down into the earth beneath a concrete waste pile neutralizes back to the neutral PH level of the moisture in the soil of earth within 10 feet vertically. If for some reason PH level would be 12 points upon in filtering a water table of PH 8.5 of which my well water is, (also my well water table is 180 feet down from the surface). So it is impossible for the PH 12 water to reach the water table as it is known), if for some weird reason it did, the PH 12 water will naturalize back to 8.5 at the water table level. The PH 12 water will drop to the 8.5 level over night, same as it happened in my experiment. This is 100% taken care of by the natural ability of the earth to neutralize every single part of the earths surface with absolutely no activity or intervention of the human attempts or factor. Here is additional information gathered during snow and rain storm water at our Rock Crushing property on this date. We also take in waste concrete and legally dried and cured concrete waste wash out to be crushed into recycled construction materials approved by Dept of Ecology.

Well water on property tested PH 8.4

Urine water tested PH 6.9 I drink the PH 8.4 water every day

Steady rain at 6:00 A.M.

Turn to snow at 8:00 A.M.

Snow water / collected from windsheild of my pickup truck. One inch on clean class windshield, so no contamination. "Tested PH 9.6"

All the rain and snow water in puddles throughout property tested PH 9.6, did the testing while it was raining and snowing so it is fresh testing as it fell into the puddles. So ! This means the snow and rain water was PH 9.6 before it hit the ground. "Out of compliance per DOE limits" ??? There was one small puddle formed by the rain and snow, strictly falling from the sky near the concrete waste pile, this tested PH 10. Was not run off from the pile of waste concrete as there was none running down the pile, obvious the rain and snow water was being soaked up by the pile of waste concrete.

They could be just the acceptable numbers written down by the person recording them, would not even need to use the meter, he could just write down numbers DOE needs to satisfy them.
