I'm emailing you today about the worst toxic pollution in Commencement Bay: The Occidental Chemical Superfund site.

For nearly 100 years, Occidental Chemical Corp. manufactured a slew of chemical solvents along the shores of the Hylebos Waterway in the Tacoma Tideflats. Over time, an unthinkable amount of these toxic chemicals entered the soil and groundwater below the site, where they remain to this day.

The resulting pollution plume truly has no comparison in the country. It's massive, and contains a variety of dangerous pollutants, including a particularly nasty group of volatile organic chemicals. Over time, these can release cancer-causing gas into our water and air. Needless to say, Occidental's pollution poses a serious and ongoing threat to wildlife and people alike.

Decades after the site was designated for cleanup, we are finally close to the start of work. The current stage in the process is tremendously important, because officials from the WA State Department of Ecology are deciding on a cleanup plan. This will determine how much of Occidental's mess gets removed, and how much stays in the ground forever.
