Re: The Safer Products for Washington Priority Consumer Products Draft Report to Legislature
(Jan. 2020; Publication 20-04-004)

To Whom It May Concern:

Tarkett submits these comments to the State of Washington Department of Ecology (Ecology) on Ecology's Priority Consumer Products Draft Report to Legislature (Draft Report), submitted as part of the Safer Products for Washington (SPW) program. We appreciate the opportunity to comment on this important initiative.

Tarkett is a global manufacturer of vinyl flooring, with vinyl production sites located in the United States, Russia, China, Brazil, Ukraine and Serbia. Tarkett is a member of the Resilient Floor Covering Institute (RFCI), an association representing the interests of the resilient floor covering industry. We support and hereby incorporate by reference the comments on the Draft Report submitted by RFCI on March 2, 2020.

As explained in more detail in the comments submitted by RFCI, a significant body of evidence demonstrates that exposure to phthalates (specifically, ortho-phthalates) in vinyl flooring (to the extent such chemicals may be present in those products) presents minimal to non-existent risk to health or safety. Concerns of health risks associated with exposure to phthalate-containing vinyl flooring are therefore misguided, as are (admittedly well-intentioned) administrative efforts to restrict those products. However, Ecology representatives have made clear, including during the February 19, 2020 public webinar regarding the Draft Report, that in implementing the SPW Program Ecology is not considering any hazard or risk information related to the products it is considering for designation as priority products. We therefore submit these comments to provide additional information regarding the dramatic reduction in use of ortho-phthalates in the manufacture of vinyl flooring by manufacturers of vinyl flooring, including Tarkett.

As discussed in RFCI's comments, vinyl flooring manufacturers have already moved away from the use of ortho-phthalates towards alternatives, including terephthalates (which, as explained in further detail in RFCI's comments, are structurally very different from the ortho-phthalates that drive the listing of "phthalates" as a priority chemical class under the SPW program). This transition was in part due to public pressure related to the "Mind the Store" campaign, whereby the largest home improvement retail chains in the United States (Home Depot, Lowes, and Menards) and

others adopted policies to phase out ortho-phthalate-containing PVC flooring by the end of 2015.¹ Because of these retail store policies, the vast majority of vinyl flooring sold in the state of Washington (and throughout the United States) is now manufactured without ortho-phthalates.²

Tarkett has been at the forefront of this industry trend. Tarkett was the first flooring manufacturer to make the decision in 2010 to stop purchasing and adding ortho-phthalates to our vinyl products. By 2013, Tarkett eliminated purchasing and adding ortho-phthalates to our vinyl flooring products manufactured in the United States. In case of vinyl products with recycled content, Tarkett limits residual phthalates to below 0.1% in mass. By the end of 2018, ortho-phthalates were no longer used in our vinyl flooring products manufactured in Europe, Serbia and China, representing 65 percent of our global vinyl flooring production. By the end of 2020, we expect to have fully transitioned remaining global sites to alternative, phthalate-free plasticizers.

Our voluntary, proactive shift towards the use of alternatives to ortho-phthalates is evidence of the wider trend within the vinyl flooring industry and demonstrates Tarkett's continued commitment to the production of safe, sustainable products—and responding to public concerns regarding perceived risk even where data demonstrate risk is minimal to non-existent. In addition to our own manufacturing practices, Tarkett is an active member of the *Responsible Use of PVC Network*. Tarkett appreciates Ecology's goals in developing and implementing the SPW program and we are happy to provide additional information if that would be useful to Ecology as it works to finalize its list of priority products.
