Hi Darlene,

Sorry you weren't able to access the webinar yesterday, but thanks for reaching out with that question.

For the cost and availability module, the statute directed Ecology to follow Interstate Chemicals Clearinghouse guidance. The IC2 guide for this module only considers material/product costs. Healthcare and environmental costs would generally be evaluated using a social impact evaluation, which was determined to be beyond the scope of this alternatives assessment. Although not specific to calculations of cost, health and environmental impacts are considered as part of the hazard and exposure modules.

Hopefully that answers your question, but please let me know if you'd like to follow-up.
