Re: Safer Products for Washington Draft Report on Regulatory Determinations

Dear Sir or Madam:

The Can Manufacturers Institute (CMI) is the national trade association of the metal can manufacturing industry and its suppliers in the United States (U.S.). The can industry accounts for the annual domestic production of approximately 130.7 billion food, beverage, aerosol, and general line cans; employs more than 28,000 people with plants in 33 states, Puerto Rico, and American Samoa; and generates about \$15.7 billion in direct economic activity.

CMI appreciates the opportunity to provide comments to the Washington Department of Ecology ("Ecology") on its *Draft Regulatory Determinations Report to the Legislature for Safer Products for Washington Implementation Phase 3* ("draft report"). The draft report identifies regulatory determinations for 11 categories of "consumer products" under RCW 70A.350.040(1). It would designate food and drink cans as a priority product for bisphenols, based on the assertion that bisphenols are a component of epoxy resins used to coat the interiors of aluminum and steel cans. With these comments, CMI hopes to contribute to a dialogue that will enhance shared understanding of the safety of can linings in the U.S. and of current can lining technology.

The comments below explain why there is not sound basis for designating food and drink cans as priority products in the Safer Products for Washington program, for reasons including but not limited to the following:

- Bisphenol A (BPA) is almost entirely phased out of domestic production of food cans. Food cans are not a significant source of exposure to BPA in the U.S.

- Can lining applications involve a cured film that does not present significant potential for migration of components to food or beverage, thus preventing potential significant exposure to components of the linings.
- The draft report calls alternate food and beverage storage methods, such as glass jars and paper cartons, “safer” because they do not contain BPA. This is not based on valid safety analysis and the broad statement that other packaging is safer is not correct.
- Discussion of the safety of the can needs to take into consideration the overall safety and sustainability profile of the packaging, including the role of cans in ensuring a safe food supply and the superior recycling rate of metal cans.
- The Washington program should acknowledge the federal legal framework for food packaging. The draft report omits the context of the current U.S. Food and Drug Administration (FDA) regulations that ensure the safety of food and beverage can linings.
- CMI welcomes the dissemination and use of assessment methodologies and voluntary certifications such as Cradle to Cradle Certified™ (C2CC), but also advises caution and proper caveats in their use. They should not become de facto regulatory mechanisms.

The remainder of CMI’s comments discuss the above points.

1. Food cans are not a significant source of exposure to BPA.

Since 2018, can manufacturers have halted the use and production of food cans using BPA linings. Well over 95 percent of all U.S. food can production has transitioned out of BPA to alternative liners. Food can linings are now made with enhanced performance acrylic, polyester, or other non-BPA epoxy linings specifically developed to achieve performance comparable to BPA-based linings. Importantly, these new lining platforms are not formulated with other bisphenol substances or any other materials that are suspected endocrine-disrupting substances. Older non-BPA can linings based on acrylic and polyester technologies have been used safely for more than 40 years.

CMI previously provided Ecology with a Market Basket Survey (“Survey”) of canned foods in Yakima and Seattle, WA, which is attached. The Survey analyzed 102 samples in the Yakima area and 132 samples in the Seattle area. None of the 102 products collected in the Yakima area had a BPA-based can lining. Of the 132 samples collected in the Seattle area, only two had a BPA-based can lining and both were imported products (coconut milk from Thailand and peaches from Australia).

The Ecology draft report concludes that restricting the use of bisphenols in can linings would reduce a significant source of exposure to people and the environment, which does not hold true for canned food, since linings with BPA essentially are phased out in U.S. food can production. Furthermore, can lining constituents in

general do not present potential for exposure in food because there is not significant migration from lining to food. This is particularly relevant if Ecology has any concerns about the potential for relatively small numbers of imported cans that might contain BPA in the lining. (It is also relevant for beverage cans as discussed under #2 below.)

Since food cans are not a significant source of exposure to BPA, the draft report proposal of a regulatory determination under 70A.350.040 for a restriction on most bisphenols in food can linings is not warranted or supported. Going forward with a new restriction for a scenario that is already nearly eliminated is unnecessary and would divert resources and attention from products that might more appropriately warrant priority in the program. It would be misleading in implying that a significant risk from BPA in food can linings currently exists and needs to be further addressed, which is not the case.

2. Food and drink can linings do not present significant potential for migration of components to food or beverage.

Food and drink can linings are formulated and applied with the result that they do not present significant potential for migration of components to food or beverage. The can lining/coating typically is comprised of high molecular weight polymer resins, cross-linkers, additives, and a blend of carrier solvent. After application of the lining in liquid form to the metal substrate, the liquid coating is baked in a high temperature oven, volatilizing low molecular weight components and carrier solvents. This high temperature bake drives the chemical reaction between the polymer resin and cross-linkers, transforming the components into a continuous polymer matrix. The cured film is designed to be inert and to not degrade. Under existing regulatory controls, cured coating inertness and stability are verified via migration testing.

Any assessment of potential exposure to BPA through food and/or beverage packaging needs to consider not only the potential presence of BPA in a lining, but also the nature and extent of the constituent's potential to migrate to the food or beverage. Given the nature of can lining technology and the regulatory controls in place, can linings are not a significant source of BPA exposure, and a Washington state restriction is not warranted for food or beverage cans.

3. The draft report designation of alternate food and beverage storage methods, such as glass jars and paper cartons, as "safer" is not supported.

The draft report refers to alternate food and beverage storage methods, such as glass jars and paper cartons, as "safer" because they do not contain BPA. It is not supported or true that glass jars and paper cartons are safer than cans. The statement deeming other packaging to be "safer" assumes that can linings are a significant source of BPA—which they are not, as discussed above—and that paper and glass food packaging are not sources of BPA in any food or beverage. Ecology does not provide substantiation that there is no BPA in these other types of packaging.

The assertion that glass and paper are safer alternatives to cans is not based on valid safety analysis, which would consider the entire safety profile of the packaging

including the strong barrier function of lined cans in preventing foodborne illness. Can packaging is essential in ensuring a safe food supply. Canned food has a shelf life of at least two years from the date of processing and an almost indefinite shelf life at moderate temperatures (75° F and below). There has not been a foodborne illness associated with canned foods in more than 40 years, and canned food as old as 100 years has been found in sunken ships and it is still microbiologically safe.

Regarding sustainability, metal cans are the most recycled food and beverage package in the U.S. This is a key component of the sustainability profile of the can and results in substantial positive environmental impact. Metal recycles forever with many cans being recycled into new cans, while certain materials like paper can only recycle a finite number of times.

CMI respectfully requests that Ecology remove any language that states or implies that paper, glass, or other packaging materials are safer than metal cans as food packaging.

4. The Washington program should include the context of the federal legal framework for food packaging.

The Washington program should consider and convey the federal legal framework for food packaging and for consumer products. Food and beverage can linings are regulated by the FDA under the authority of the Federal Food, Drug, and Cosmetic Act (FFDCA). The FDA regulatory framework assures the safety of food contact materials including food and beverage can linings. Every lining component is evaluated for safety by the FDA via a specific listing in the Federal Register or by a comprehensive pre-market review. FDA requires extensive data about new food contact substances as part of the Food Contact Notification process. The regulations at 21 CFR 175.300 address polymers as food contact substances, but these regulations and the FDA in general are not mentioned at all in the draft report discussion of food and beverage cans. We think this is an important omission of the context of the current framework in place to ensure the safety of food and beverage can linings.

The federal legislative and regulatory framework distinguishes between “consumer products” and food and food contact substances, recognizing that they warrant different requirements. Consumer products are regulated under Consumer Product Safety Act (CPSA) (15 U.S.C. 2079(a)) by the Consumer Product Safety Commission (CPSC). CPSC’s jurisdiction is governed by the definition of *consumer product* at CPSA section 3(a)(5), which explicitly excludes materials that are regulated by the FDA. Food and food contact materials are by definition not consumer products in the federal framework, but rather are within the jurisdiction of the FDA.

The Washington legislation applies to consumer products. CMI understands that Washington state may choose to define *consumer product* more broadly than federal laws, but the federal framework is still relevant as it is tailored to addressing potential risks via food and beverage packaging. It is not necessary and would not be

effective to attempt to regulate food and food contact materials in a state consumer products program.

States sometimes do go above and beyond federal law if there are gaps that leave risks to human health or the environment unaddressed. However, this is not the case for food packaging, which is subject to tailored and comprehensive federal requirements. It is not sound science or appropriate public policy for a state agency to attempt to implement controls on food and food packaging that differ from those under existing U.S.-wide FDA oversight.

5. Assessment methodologies and voluntary certifications need to be used appropriately and with proper caveats.

CMI welcomes the dissemination and use of assessment methodologies and voluntary certifications such as Cradle to Cradle Certified™ (C2CC). At the same time, CMI advises caution and proper caveats in the use of C2CC, particularly by regulatory agencies. Ecology appears to be relying exclusively on C2CC to make a determination of whether “safer” alternatives are available. Some of the statements made in the draft report could be read to imply there are no safe alternatives for BPA-containing linings in food cans, just because none have gone through this particular voluntary certification process.

The draft report and Ecology’s process should be clear that C2CC is a voluntary and private process and not a de facto regulatory process or determination, and that all can linings are regulated by the FDA. We think it is appropriate for Ecology to refer to and coordinate with the FDA in any determinations about the safety of food can linings. The draft report’s exclusive focus on the C2CC process in its discussion of alternatives loses sight of the important fact that alternatives currently in use are all evaluated as safe under established FDA methods and rules.

6. Washington Ecology needs to ensure that any information provided to the public is accurate.

Washington Ecology and the Washington Department of Health should ensure that all information they provide to the public is accurate. Overly broad or incorrect statements do not serve to protect the public, but rather have the potential to alarm and mislead. For instance, in a recent blog post, the Washington State Department of Health states that “many of the toxic chemicals that get into our bodies, our food, and our environment come from chemicals used to make everyday household products” including food and drink can linings.¹ There is no support for the assertion that many of the toxic chemicals affecting health and the environment come from food and drink can linings.

Removing food and beverage can linings from designation as a priority product will advance the overall goal of providing accurate information. As explained herein, making such a priority product designation is contrary to the current reality that food and drink cans are not a significant source of exposure to BPA.

In summary, it is not necessary or justified to move forward with any restriction on bisphenols in food or drink can linings under the Safer Products for Washington program. Ecology should remove the proposed determinations from the report and should not move forward with a rulemaking process to develop the regulatory actions for cans. If Ecology does take further action to designate food and/or drink cans as priority products or begin any rulemaking that affects them, actions should go forward with full transparency and continued input from stakeholders including CMI and its members.

The Can Manufacturers Institute (CMI)¹, the national trade association of the can manufacturing industry and its suppliers, submits the attached report “CMI Washington State Canned Food Market Basket Survey” as a follow-up to CMI comments² submitted to the Washington State Department of Ecology (DOE) on March 2, 2020.

Our March 2, 2020, comments were in response to the DOE’s request for input from stakeholders regarding its January 2020 legislative report, “Priority Consumer Products Draft Report to Legislature – Safer Products for Washington Implementation Phase 2,” which was finalized in July 2020.

Of interest to CMI, the final report published in July 2020 and transmitted to the Legislature, suggests that one of the largest sources of exposure to bisphenol A (BPA) is from food. However, since 2018, can manufacturers have halted the use and production of food cans using BPA linings and prioritized the development and use of alternative can linings that are based on polymers that include acrylic, polyester, and/or non-BPA epoxy. In fact, more than 95 percent

of all U.S. food can production has transitioned out of BPA to alternative liners. Current industry information on can linings, specifically the reformulation of can linings without BPA, can be found on the CMI website at <http://www.cancentral.com/content/innovations-food-cans>.

To provide data specific to Washington State, directly relevant to the Safer Products for Washington Program, CMI has completed a Market Basket Survey ("Survey") of canned foods in Seattle and Yakima, WA, which is attached. The Survey analyzed 132 samples in the Seattle area and 102 samples in the Yakima area. The Survey found only two cans using a BPA-based liner, both of which included imported products from Thailand and Australia. Phase 2 of the Safer Products for Washington Program seeks to determine what consumer products contain certain priority chemicals (e.g., phenolic compounds - bisphenols). The recent Survey concludes that nearly no bisphenols are contained in canned foods, thus there is no significant exposure to the people of Washington State to bisphenols from canned food. **CMI urges DOE to remove food cans as a priority product associated with exposure to phenolic compounds from the priority product report transmitted to the Legislature in July 2020.**

Introduction

The Pollution Prevention for Healthy People and Puget Sound Act (the Act), creates a process for the Washington State Department of Ecology (DOE), in consultation with the Washington State Department of Health, to regulate classes of chemicals in consumer products. The DOE has created the “[Safer Products for Washington](#)” program (the Program) to implement the Act. This program requires the DOE to designate priority chemicals, identify products that contain these chemicals, determine regulatory actions, and adopt rules to implement regulatory actions. The Act requires that safer alternatives are feasible and available to promulgate restrictions on the use of a priority chemical. The program outlines steps that involve stakeholder consultation, legislative reporting and rulemaking.

The Program establishes a process to:

- Designate priority chemicals.
- Identify products that contain these chemicals.
- Decide whether or not to regulate those chemical-product combinations by requiring reporting or chemical restrictions.
- Adopt rules to implement those regulatory actions.

In January 2020, the DOE published [the Priority Consumer Products Draft Report to the Legislature: Safer Products for Washington Implementation Phase 2](#). The release of the draft report was followed by a webinar hosted by the DOE to present their rationale. A public comment period was open until March 2.

The [draft report and webinar presentation](#) cited dated information regarding the prevalence of bisphenol-A (BPA) based epoxy can liners use in canned foods. During the webinar presentation, the DOE acknowledged receiving information regarding retailer agreements to move away from selling vinyl flooring with ortho-phthalates, another product and priority chemical under review. Importantly, the DOE indicated they were working on confirming this information and would take all new data into account. This report summarizes the current market for can linings and finds the prevalence of epoxy based BPA linings is approaching zero.

The Can Manufacturers Institute Science, Technology and Regulatory Committee (the Committee) submitted [written comments](#) to the DOE to provide the latest information regarding the industry’s transition to alternative can liners and dispel speculation regarding the use of BPA analogs in alternative can liners. While [can industry statistics](#) indicate more than 95 percent of all U.S. food can production has transitioned out of BPA to alternative liners there was no data regarding food cans currently in the market place. To address this data gap the Committee conducted a Market Basket Survey (the Survey) of canned foods in Seattle and Yakima.

Survey Design and Experimental Methods

Sampling

The intent of the Survey was to provide the DOE with up to date information on canned food in commerce to shed light on consumer exposure to BPA in Washington State. Comprehensive evaluation of all demographics was a prime consideration. Sampling plans took multiple factors into account population, geography, and discount to up-scale retailers, small producers to National Brands and a wide variety of food products relevant to all age groups.

Market Basket surveys have been conducted in the recent past. Most noteworthy was the [Buyer Beware report](#) by Breast [Cancer](#) Fund, Campaign for Healthier Solutions, Clean Production Action, Ecology Center, Mind the Store Campaign published in late 2016. That survey involved 192 samples of canned foods capturing a wide range of food products, from a full range of retailers, brands and can types.

With the Buyer Beware report in mind, the Survey sampling plan attempted to replicate the sampling of the Buyer Beware survey to the greatest extent possible including specific retailers, brands and products. Since the intent of the Survey was to inform the DOE on exposures to the citizens of Washington State, the nationwide scope of the Buyer Beware was translated into a focused sampling of the Seattle (est. pop. 3.4 million) and Yakima (est. pop. 98,884) areas during the last week of February and first week of March 2020.

Efforts to replicate the sampling of the Buyer Beware were largely successful in both Seattle and Yakima markets despite the several year time span and effects of the COVID-19 impacts to on-shelf availability of products. In some instances, where exact product matches were not available, relevant substitutions were made such as fruit in light syrup substituting fruit in heavy syrup or substituting a discontinued private label brand with a different private label brand. Overall, relative to the 192 samples in the Buyer Beware survey, 132 samples were collected in Seattle and 102 samples were collected in Yakima for a total of 234 samples in the Survey. The disparity of 132 or 102 samples of the Survey verses the 192 samples of the Buyer Beware is primarily attributed to the lack of retailer presence in either Seattle or Yakima as opposed to any disparity of actual food products. For example, red kidney beans from Whole Foods Market, FreshCo or Gordon Food Service are not available in the Yakima area but red kidney beans from Walmart, Safeway, and Dollar Tree are present in the Survey.

Samples were labeled on both ends with a variable number corresponding to one of the 192 samples in the Buyer Beware report. Product, manufacturer, retailer, best by date and can manufacturer code information was logged. Can labels were removed, labeled with the corresponding variable number and retained along with sales receipts. Cans were opened, emptied, washed and allowed to air dry.

Experimental

Accurate material identification is critical to the can manufacturing industry and Fourier-transform infrared (FTIR) spectroscopy is the standard analytical technique utilized by the industry for can liner identification.

Cans collected in Seattle were analyzed using a Nicolet iS10 FT-IR Spectrometer, with a Smart iTX ATR diamond accessory, while cans collected in Yakima were analyzed using a Nicolet 6700 FT-IR Spectrometer with a Smart Orbit ATR diamond accessory.

Spectra were collected from the can body and end or ends depending on whether the variable was a two piece can with an integral end or a three piece can with two ends.

Liner Identification

Liners were identified by an instrumental library search matching the FTIR spectrum collected from the sample with that of a known commercially available can liner. The very distinct difference in molecular structure between the different classes of can liner chemistries (acrylic, BPA-based epoxy, non-BPA based epoxy, polyester and vinyl) in commercial use allows the can liners to be readily identifiable from their FTIR spectrum.

Survey Results

Summary

Of the 132 samples collected in the Seattle area only two utilized a BPA-based liner and both of those were imported products: coconut milk from Thailand and peaches from Australia. None of the 102 products collected in the Yakima area utilized a BPA-based liner.

Analysis and Discussion

A lengthy supply chain from raw material production, can manufacturing, product seasonality, warehousing and distribution all factor into a diffuse timeline for a market to reflect changes from when they occur. The vast majority of food can production in the United States had transitioned to non-BPA liners by the end of 2017 and at more than 95 percent by the end of 2019 for cans produced for the U.S. market.

The Buyer Beware report published in late 2016 predominantly captured products with Best by Dates between 2016-2018 reflecting cans manufactured during 2014-2016. The survey reported 67 percent of products utilizing BPA liners with the balance using Acrylic, Oleo-resinous, Polyester or Vinyl liners capturing a period of transition within the industry.

In contrast, the Survey has captured products after the industry has transitioned out of BPA liners. Products with Best by Dates between 2019-2021 reflecting cans manufactured between 2016-2019

predominantly utilizing non-BPA alternative, Acrylic or Polyester liners, and some non-BPA legacy Vinyl liners that have been in commercial use for decades.

Analysis of the two products found to be using BPA liners shaded below is detailed in Tables #1 and #2 with survey results for coconut and fruit products. In both cases it is evident that these product categories have also transitioned out of the use of BPA-based epoxy liners into alternative liners.

The Survey captured 13 samples of coconut products from nine (9) different brands. The coconut product packed with a BPA-based epoxy end was one of three samples collected for this specific product.

Conclusion

Linings used for canned foods available to Washington consumers are no different than those linings used for canned foods nationwide. This also applies to the food types and products with nationwide distribution. While not exhaustive, there was no evidence of any disparity in results across geography, retailer, food category or brand in the Washington State market.

Based on the direct knowledge of can manufacturers as to what can liners are in current commercial production and the Survey results it is evident that food cans with BPA-based liners are no longer prevalent in the market place, so therefore not a significant source of BPA exposure to consumers in Washington State. Hence, DOE can feel confident in removing food cans as a source of BPA exposure in their report.

As discussed in the Sampling section of the report, the exact Buyer Beware survey product, retailer combinations were not always available for inclusion in this survey. Columns without entries correspond to products not collected in this survey. Also, it should be noted that one sample of the 192 reported in the Buyer Beware report did not have an entry for the product identity leading to this survey's results table having 191 targeted products.

The Can Type determines whether the container has one or two seamed ends. A two piece can has a body with an integral end and one seamed end. A three piece can has a body with two seamed ends.

Results reported as "Plain" correspond to bare uncoated tin plated steel.
