Addendum G, Table G-7 The Two-way radio locations are labeled as "varies".

#### **Response**

Please update the location of the two-way radios, in Addendum G, Table G-7, to be specific. There are two base station radios in building 6 and building 8. There are 37 hand-held radios with key staff at all times during working hours. Site security has a radio 24 hours per day. This should also be revised in section G.5.5 to read "Hand-held, two-way radios or cell phones are carried by the EC, the EC alternates, unit supervisors, and security personnel."

## **Comment 3**

Addendum G, G.7.10 The directions to the hospital here are inaccurate due to construction changes.

#### **Response**

Add the updated directions to Addendum G, Section G.7.10 as follows:

1. From Logston Rd

- 2. Turn Right on Battelle Blvd
- 3. Go east to Stevens Drive. 0.7 miles
- 4. Turn right on Stevens
- 5. Go south for 2.4 miles.
- 6. Turn left to Jadwin Ave
- 7. Go south on for 2 miles
- 8. Turn right on Swift Blvd
- 9. Go west for 0.3 miles
