General Information

Ecology is proposing to modify Packaging Corporation of America's (PCA's) Air Operating Permit and Notice of Construction Order 02AQIS-3588. Ecology has issued a State Environmental Policy Act (SEPA) Determination of Non-Significance (DNS) associated with the modification of the Notice of Construction Order. The documents are available for public comment.

PCA is a kraft and recycled pulp and paper mill and corrugated container plant.

- With around 400 employees, the pulp and paper mill makes about 1,800 tons of unbleached paper and corrugated cardboard each day.
- The container plant has about 155 employees and makes approximately 5 million square feet of corrugated boxes each day.

This facility is classified as a major source of air pollution.

Location

PCA is located at 31827 US-12, Wallula, Washington, in Walla Walla County.





Modification to the permits

The proposed modifications do not allow for an increase in emissions or construction of new equipment.

Proposed modifications to the Notice of Construction Order 02AQIS-3588 include:

- The requirement to monitor sulfur dioxide emissions from the hogged fuel boiler more accurately, using site-specific information rather than assumed operating conditions.
- A reduction in the stack testing frequency of particulate matter at the no. 3 recovery furnace and hogged fuel boiler based on a history of measured emissions being well below the limit.

Proposed modifications to the air operating permit include:

- The incorporation of the changes to Notice of Construction Order 02AQIS-3588 described above.
- The incorporation of new or modified requirements from Notice of Construction Orders previously issued or modified in 2018 and 2020.
- More accurately capturing existing requirements that the Permittee is subject to for their operation of the no.2 recovery furnace, and the collection and treatment of regulated condensates.

SEPA Determination of Non-Significance

We have reviewed the Environmental Checklist for the proposed Notice of Construction Modification and determined that this proposed modification will not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030(2)(c).

A tentative virtual public meeting followed by a hearing to provide information on the modifications and receive comments from the public is scheduled for December 16, 2025, on ZOOM at 6:00 p.m. Register online at https://waecy-wa-gov.zoom.us/meeting/register/iSUxEc5mTQqKDsb-U06PeA. Registration is required. After registering, you will receive a confirmation email containing information about joining the hearing. The public hearing will be held if Ecology receives significant public interest. Ecology will notify interested parties prior to cancelling the tentative public hearing if we have not received significant interest by December 15, 2025.

What happens next?

When the comment period ends, we will review all comments received and make appropriate changes to the permits before finalizing the permits.
