# **Documents ready for public review and comment**

The Department of Ecology invites you to review and comment on the draft First Periodic Review and associated documents for the US Army Camp Bonneville Cleanup Site located at 23201 NE Pluss Road, Vancouver, Clark County. The document calls for amending cleanup action plans, where needed, to add additional or revise existing institutional controls, and provides recommendations to address issues identified during the review process. You are invited to review and comment on the following documents:

- Draft First Periodic Review: Ecology reviewed current and postcleanup site conditions and monitoring data to ensure human health and the environment are being protected.
- **Draft Updated Public Participation Plan** is Ecology's outreach plan. It describes how we will contact the public about this site, and opportunities for public input.


# After the comment period, Ecology will:

- Publish all the input we received and respond to significant comments and questions, as appropriate. If the comments result in significant changes to the cleanup documents, then the documents will be revised and re-issued for public review. If the comments do not result in significant changes, the documents will become final.

# **Public Input During Washington's Cleanup Process**

The Model Toxics Control Act (MTCA¹) is Washington's environmental cleanup law. MTCA funds and directs the investigation, cleanup, and prevention of sites that are contaminated by hazardous substances. It works to protect people's health and the environment, and to preserve natural resources for the future.

MTCA requires 30-day public comment periods throughout the cleanup process (Figure 2). **Currently, we are accepting comments on a draft first periodic review and a public participation plan.**


