This is due to the change in Washington law requiring marine net pens to raise only native species of fish. As a result, Cooke Aquaculture Pacific will no longer be allowed to sustainably raise Atlantic salmon in Washington state.

Steelhead trout are a native species to Washington and triploids cannot reproduce, therefore mitigating any opportunity for wild-farmed fish interactions.
