Proposed amendments to the

Cruise Ship Memorandum of Understanding

Public comment period: Feb. 17 to March 19, 2021

The Department of Ecology, Port of Seattle, and Northwest Cruise Ship Association negotiated a MOU in

2004 to establish voluntary actions aimed at improving the treatment of waste discharges from cruise

ships operating in Washington waters. The waters subject to the MOU include the Puget Sound and the

Strait of Juan de Fuca south of the international boundary with Canada; and along Washington's Pacific

Coast extending for three miles seaward. The original Memorandum was signed on April 20, 2004.

The current MOU as written has an amendment process every three years; at which time proposed amendments from MOU parties as well as from the public are requested and reviewed. The most recent call for proposed amendments ended on December 18th

. After the close of the proposed

amendment request, the MOU parties have 45 days to review the proposed amendments to verify they

meet the requirements for further review and then put the proposed amendments out for a 30-day public comment period.

In the most recent review of the proposed amendments, the MOU parties have agreed that two amendment proposals meet the MOU's requirements for consideration. Ecology is opening a 30 day public comment period beginning February 17th to review the proposed amendments. The proposed amendments have not yet been adopted by the MOU parties. Adoption of the proposed amendments and final language of any amendments to the MOU will be determined by the MOU parties after the public comment period has ended.

The two proposed MOU amendments are listed below. Please use the ecomments form to comment on

Proposed MOU amendments:

1) Institute a ban on the discharge of exhaust gas scrubber washwater from all scrubber types, including bleed off or sludges, in MOU waters.

This proposed MOU amendment met the criteria as it was specific to the MOU waters and was accompanied by scientific data to support the amendment. However, if adopted, some of the wording of this amendment is likely to change to conform with regulations under the MARPOL treaty regarding exhaust gas scrubber washwater.

2) Ecology proposes to incorporate the Vessel Sewage No Discharge Zone (NDZ) for Puget Sound into the MOU to reflect the Washington state NDZ regulation. Chapter 173-228 Washington Administrative Code (WAC), adopted on April 9, 2018, and effective May 10, 2018. Additional information is available online at

<https://ecology.wa.gov/Water-Shorelines/Puget-Sound/Nodischarge-zone>. As written, the MOU allows for treated sewage (blackwater) discharges after

advanced wastewater treatment that are now not allowed by the NDZ regulation. To be consistent with the regulation and to prevent vessel sewage discharges in MOU waters, all

allowances of the sewage discharges in MOU waters should be prohibited. This would not affect graywater discharge in the MOU.
