Dear Director Sixkiller:

Zeem Solutions (Zeem) appreciates the opportunity to provide comments on the ZEvergreen Public Dialogue Session and applauds the Department of Ecology for engaging with stakeholders. We recommend providing continuous and predictable funding for the WAZIP program. Long-term signals support a robust market for commercial ZEVs and upfront cost of the vehicle remains the biggest barrier to adoption. Additional considerations should include incentives for infrastructure, including battery storage, and protecting the Clean Fuel Standard. We look forward to continued engagement with Department of Ecology staff throughout this process.

About Zeem

Zeem is a nationwide charging provider that designs, builds, and operates shared charging depots for commercial fleets. Zeem provides a range of services, including charging infrastructure, fleet management, and electric vehicle (EV) financing, which facilitate a seamless and cost-effective transition to zero-emission solutions for commercial fleets. In addition to building shared depots, Zeem offers a proprietary on-site modular charging and energy management solution that installs in a fraction of the time and reduces the risk of obsolescence. Our charging depots are strategically located across the country, situated near key logistics hubs such as seaports, airports, and distribution centers. Our flagship depot is fully operational and located adjacent to Los Angeles International Airport, construction at our Long Beach, CA Depot is almost complete. Zeem is deploying a commercial charging depot in SeaTac, WA.

Zeem's depots are secure charging hubs that are open to any contracted fleet customer, including large companies and independent owner-operators. Depots are open and staffed 24/7, allowing both daytime and overnight charging. Depots have bathrooms, shared office spaces, vehicle maintenance shops, and personal vehicle parking spaces when site space allows for it. Fleets of all sizes can choose the exact class and configuration of vehicle they need and operate it under an all-in lease and/or depot services agreement that includes white glove charging, regular maintenance and cleaning, secure parking, and 24/7 operations at conveniently located facilities.

Zeem operates two charging sites in Inglewood, CA, near LAX, and launched in December 2021. The sites span 3.1 acres, with 82 fast charging ports and 53 Level 2 chargers, providing up to 7.5MW of charging power. The LAX depot supports over 20,000 charging sessions per month and can serve



up to 250 MHD EVs on-site. The site optimizes charging operations through real-time data collection to meet fleet needs efficiently. In 2024, Zeem completed over 5.5 million kWh of charging, showcasing our ability to manage large-scale, multi-fleet EV operations.
