To the DRBC Commissioners:

Thank you for providing me and all concerned citizens the opportunity to comment. As a resident within the Delaware River Watershed, a concerned citizen, and Chair of the Water Issues Committee for the Atlantic Chapter of the Sierra Club, I call for a COMPLETE BAN on ALL activities related to unconventional HVHF drilling for natural gas, a/k/a fracking, within the Delaware River Watershed and Basin.

I oppose any proposal to allow water from the Delaware River Watershed to be withdrawn for use in unconventional drilling. I support a full and permanent ban on fracking and its activities throughout the Delaware River Watershed.

Despite the indisputable fact that the world is facing a future of water scarcity, the fuel energy industry will usurp as much water as possible for drilling purposes, such as they have in the town of Erwin, NY from an intentionally obscured water source, during a drought from a SRBC designated already stressed aquifer.
