IMAGINE FOR A MOMENT – THAT YOU CAN NO LONGER DRINK YOUR WATER BECAUSE AN INCIDENT HAS TAINTED YOUR TAP WATER, YOUR WELL, OUR RIVER. THAT YOU CAN'T EAT THE FISH BECAUSE THEY HAVE BEEN POISONED. THAT YOU CAN'T FEED YOUR FARMED CROPS BECAUSE THE WATER IS UNSAFE. AS AN OLD AFRICAN PROVERB STATES, 'FILTHY WATER CANNOT BE WASHED'.

PLEASE PUT A PRIORITY ON THE HEALTH AND WELFARE OF THE RESIDENTS OF OUR STATE – OVER THE PROFITEERING INTERESTS OF AN INDUSTRY - THAT HAS BEEN ENTITLED TO EXPLOIT OUR STATE'S NATURAL RESOURCES FOR FAR TOO LONG.
