Doctor Barnaby Ruhe speaking: The Ruhe family have been Allentown residents since the 1750s:

You of the DRBC should know that your vote to allow Fracking Wastewater-Brine-Floback- to enter the Delaware Watershed WOULD BE a violation of your public trust- water is a public trust -and you are the trustees of our water. and we trust you. You look like good people.

When you are in court listening to the sick and dying they will say your name over and over. You did it.
