The Washington Department of Fish and Wildlife is inviting the public to comment on the scope of a post-recovery plan for wolves in Washington. Scoping helps us identify reasonable actions, alternatives, and impacts to be discussed in the plan. Scoping improves decisions and encourages collaboration, cooperation, and early resolution of potential conflicts. It is intended to narrow the focus of the plan to the relevant issues. **The public scoping comment period for this process is open from August 1, 2019 through November 1, 2019.**

## Comments on the scope of the post-recovery wolf conservation and management plan:

Need to restore trust in WDFW people & process. At the least they shouldn't appear anti-livestock. Multiple collars in every pack & real-time data available to producers. Removal of the only collar doesn't change pack behavior but it seems to provide an excuse to stop or slow down lethal removal. Stop blaming declining deer & elk populations on everything but predators. Lots of causes possibly but predation has got to be part of the narrative. Educate public & environmental groups that not all depredations of livestock occur on "their" land - some of us have losses from our private ranges.
