Receiving water: Pomme de Terre River - Class 2Bg, 3, 4A, 4B, 5, 6 water

Description of Permitted Facility

The application and plans indicate that the existing Class A Facility consists of one main lift station, approximately 3,000 feet of six-inch forcemain, a mechanical bar screen, grit chamber, an oxidation ditch, two secondary clarifiers, two traveling-bridge sand filters, UV disinfection and approximately 600 feet of outfall pipe. Biosolids treatment consists of three aerobic digesters and 16 drying beds. The Facility also maintains auxiliary chlorine disinfection and dechlorination equipment to be used as needed to treat peak flows.

The Facility has a continuous discharge (SD001) to the Pomme de Terre River and is designed to treat an average wet weather (AWW) flow of 0.440 million gallons per day (MGD). The Facility has an average annual flow of 0.389 MGD, a dry weather design flow of 0.365 MGD, and is designed to treat a five-day carbonaceous biochemical oxygen demand of 294 milligrams per liter.

The preliminary determination to reissue this Wastewater permit is tentative.

Procedure for public participation

Submitted comments or petitions must state:

- 1) Your interest in the permit application or the draft permit.
- The action you wish the MPCA to take, including specific references to the section of the draft permit you believe should be changed.
- The reasons supporting your position, stated with sufficient specificity as to allow the MPCA to investigate the merits of the position.

Public informational meeting

A public informational meeting is an informal meeting during which interested persons can ask questions concerning the proposed facility. MPCA staff will be present to provide information. If an interested person would like the MPCA to hold a public informational meeting, the person should include all information identified above and in addition include a statement of the reasons the person desires the MPCA to hold a public informational meeting and the issues that the person would like the agency to address at the public informational meeting.

Contested Case Hearing

A contested case hearing is a formal proceeding before an administrative law judge empowered to advise the MPCA regarding issues of fact. As described in Minn. R. 7000.1800, persons who submit petitions for a contested case hearing must also state the issues they propose to address in a contested case hearing, the specific relief requested or resolution of the matter, and the reasons (which may be in the form of proposed findings) supporting an MPCA decision to hold a contested case hearing. Failure to comply with these rules exactly may result in a denial of the request. To the extent known, the petitioner may also submit a list of prospective witnesses to be called at a hearing, a proposed list of publications, references, or studies to be introduced at a hearing and the approximate time required for the petitioner to present the matter at a hearing. The decision whether to hold a contested case hearing will be made under Minn. R. 7000.1900.
