## **Description of permitted facility**

The Lonsdale Wastewater Treatment facility (facility) is located at 835 Industrial Park Drive Southeast, Lonsdale, Minnesota 55046-4017, Rice County. This is a Class B facility.

The existing facility is designed to treat:

- an average wet weather design flow of 0.687 million gallons per day (MGD);
- an average dry weather design flow of 0.493 MGD;
- a peak hourly wet weather flow of 3.24 MGD:
- a five-day carbonaceous biochemical oxygen demand strength of 200 milligrams per liter (mg/L); and
- a total suspended solids concentration of 250 mg/L.

The existing facility consists of influent screening and grit removal, two extended aeration-activated sludge basins, chemical phosphorus removal, two final clarifiers, and ultraviolet (UV) light disinfection. Biosolids are treated in an aerobic digester and land applied to approved agricultural sites. There are no bypass points known to exist in the treatment system.

The facility has a continuous discharge (Station SD003) to an unnamed ditch (Class 7, 3C, 4A, 4B, 5, 6 water) that flows into Union Lake.

### Description of preliminary variance request determination

The Minnesota Pollution Control Agency (MPCA) issues this document to notify the public of the Commissioner's preliminary decision regarding the variance requested by the Permittee. The Permittee has applied for a variance from the total chloride water quality standard for Class 2B waters (used to generate water quality based effluent limit) that is governed by the Permittee's National Pollutant Discharge Elimination System/State Disposal System (NPDES/SDS) permit. Upon review of the documents, the Commissioner has made the preliminary determination that the Permittee has satisfied the conditions necessary to grant the variance and as a result, the Commissioner has made the preliminary determination to grant the variance.

The preliminary determination to reissue this wastewater permit is tentative.

### **Water Quality Variance Public Meeting**

For the chloride water quality variance, as required by Minn. R. 7050.0190, subp. 6, the Commissioner has scheduled a public meeting at the following time and location:

The meeting will have a brief presentation on the variance, an opportunity to ask clarifying questions, and a period to make verbal comments regarding the preliminary variance decision. Please notify the MPCA within 14 days after the start of this public notice if you would like to request a translator or interpreter for the upcoming public meeting.

The meeting will be recorded and made available upon request.

## Procedure for public participation

As stated in Minn. R. chs. 7000 and 7001, there are three formal procedures for public participation in the MPCA's consideration of this matter. Interested persons may:

- 1) Submit written comments on the draft permit.
- 2) Petition the MPCA to hold a public informational meeting.
- 3) Petition the MPCA to hold a contested case hearing.

## **Submitting written comments**

Submitted comments or petitions must state:

- 1) Your interest in the permit application or the draft permit.
- The action you wish the MPCA to take, including specific references to the section of the draft permit you believe should be changed.
- The reasons supporting your position, stated with sufficient specificity as to allow the MPCA to investigate the merits of the position.

## **Public informational meeting**

A public informational meeting is an informal meeting during which interested persons can ask questions concerning the proposed facility. MPCA staff will be present to provide information. If an interested person would like the MPCA to hold a public informational meeting, the person should include all information identified above and in addition include a statement of the reasons the person desires the MPCA to hold a public informational meeting and the issues that the person would like the agency to address at the

public informational meeting.

## **Contested Case Hearing**

A contested case hearing is a formal proceeding before an administrative law judge empowered to advise the MPCA regarding issues of fact. As described in Minn. R. 7000.1800, persons who submit petitions for a contested case hearing must also state the issues they propose to address in a contested case hearing, the specific relief requested or resolution of the matter, and the reasons (which may be in the form of proposed findings) supporting an MPCA decision to hold a contested case hearing. Failure to comply with these rules exactly may result in a denial of the request. To the extent known, the petitioner may also submit a list of prospective witnesses to be called at a hearing, a proposed list of publications, references, or studies to be introduced at a hearing and the approximate time required for the petitioner to present the matter at a hearing. The decision whether to hold a contested case hearing will be made under Minn. R. 7000.1900.
