Description of permitted facility

Existing Facility

The facility discharges from monitoring station WS 006 (Frontenac Heritage Acres 3rd Addition) and from monitoring station WS 009 (Frontenac Heritage Acres 2nd Addition) to two subsurface drainfields. This is a Class D facility.

The facility is designed to treat:

1. Frontenac Heritage Acres 2nd Addition (FHA 2) - Up to 16 residential homes.

- an average wet-weather (AWW) flow of 7,760 gallons per day (gpd),
- daily maximum flow of 11,640 gpd, and
- five-day carbonaceous biochemical oxygen demand (CBOD₅) of 14.2 pounds per day (lb/day).

The facility for FHA 2 consists of two-inch diameter pressure sewer collection with individual grinder pumps that discharge into three 6,000-gallon septic tanks in series, effluent screen, and flows by gravity to a dual zoned drainfield.

The facility is designed to treat:

2. Frontenac Heritage Acres 3rd Addition (FHA 3) - Up to 53 residential homes.

- an AWW flow of 19,875 gpd,
- daily maximum flow of 29,812 gpd,
- CBOD₅ of 29.15 lb/day, and
- total suspended solids (TSS) of 33 lb/day.

The facility for FHA 3 consists of a gravity collection that discharges into four 12,000-gallon septic tanks in series, effluent screen, and flows by gravity to a six zoned drainfield. Each zone has 2,880 lineal feet of rock trench. There is one upgradient and two

downgradient monitoring wells.

Total permit flow is 27,635 gpd. There are no designed bypass points known to exist in the treatment system.

The preliminary determination to reissue this wastewater permit is tentative.

Procedure for public participation

As stated in Minn. R. chs. 7000 and 7001, there are three formal procedures for public participation in the MPCA's consideration of this matter. Interested persons may:

- 1) Submit written comments on the draft permit.
- 2) Petition the MPCA to hold a public informational meeting.
- 3) Petition the MPCA to hold a contested case hearing.

Submitted comments or petitions must state:

- 1) Your interest in the permit application or the draft permit.
- 2) The action you wish the MPCA to take, including specific references to the section of the draft permit you believe should be changed.
- 3) The reasons supporting your position, stated with sufficient specificity as to allow the MPCA to investigate the merits of the position.

Public informational meeting

A public informational meeting is an informal meeting during which interested persons can ask questions concerning the proposed facility. MPCA staff will be present to provide information. If an interested person would like the MPCA to hold a public informational meeting, the person should include all information identified above and in addition include a statement of the reasons the person desires the MPCA to hold a public informational meeting and the issues that the person would like the agency to address at the public informational meeting.

Contested Case Hearing

A contested case hearing is a formal proceeding before an administrative law judge empowered to advise the MPCA regarding issues of fact. As described in Minn. R. 7000.1800, persons who submit petitions for a contested case hearing must also state the issues they propose to address in a contested case hearing, the specific relief requested or resolution of the matter, and the reasons (which may be in the form of proposed findings) supporting an MPCA decision to hold a contested case hearing. Failure to comply with these rules exactly may result in a denial of the request. To the extent known, the petitioner may also submit a list of prospective witnesses to be called at a hearing, a proposed list of publications, references, or studies to be introduced at a hearing and the approximate time required for the petitioner to present the matter at a hearing. The decision whether to hold a contested case hearing will be made under Minn. R. 7000.1900.
