Watershed: Upper Iowa River

Receiving water: Pine Creek - Class 7, 3, 4A, 4B, 5, 6 water

Description of permitted facility

Existing Facility

The existing facility has a continuous discharge from SD 003 to Pine Creek. This is a class B facility.

The facility is designed to treat:

- an average wet-weather (AWW) flow of 0.194 million gallons per day (MGD),
- an average dry-weather (ADW) flow of 0.120 MGD,
- peak hourly wet-weather (PHWW) flow of 0.600 MG, and
- five-day carbonaceous biochemical oxygen demand (CBOD₅) of 324 pounds per day (lb/day).

The facility consists of two lift stations, mechanical screening, grit removal, a primary clarifier, a trickling filter, intermediate clarifiers, aeration basins, final clarifiers, chlorine contact basin with dechlorination, an anaerobic digester, sludge drying beds, and a sludge storage tank.

Proposed Facility

The facility is constructing a new ultraviolet disinfection system and installing a new effluent flow meter. No other changes are proposed.

The only portions of this major modification that are open for public comment are the proposed construction schedule, flow monitoring and phased limit for total residual chlorine.

The preliminary determination to modify this wastewater permit is tentative.

Procedure for public participation

As stated in Minn, R, chs. 7000 and 7001, there are three formal procedures for public participation in the MPCA's consideration of this matter. Interested persons may:

- 1) Submit written comments on the draft permit.
- 2) Petition the MPCA to hold a public informational meeting.
- 3) Petition the MPCA to hold a contested case hearing.

Submitting written comments

Submitted comments or petitions must state:

- 1) Your interest in the permit application or the draft permit.
- The action you wish the MPCA to take, including specific references to the section of the draft permit you believe should be
- The reasons supporting your position, stated with sufficient specificity as to allow the MPCA to investigate the merits of the position.

Public informational meeting

A public informational meeting is an informal meeting during which interested persons can ask questions concerning the proposed facility. MPCA staff will be present to provide information. If an interested person would like the MPCA to hold a public informational meeting, the person should include all information identified above and in addition include a statement of the reasons the person desires the MPCA to hold a public informational meeting and the issues that the person would like the agency to address at the public informational meeting.

Contested Case Hearing

A contested case hearing is a formal proceeding before an administrative law judge empowered to advise the MPCA regarding issues of fact. As described in Minn. R. 7000.1800, persons who submit petitions for a contested case hearing must also state the issues they propose to address in a contested case hearing, the specific relief requested or resolution of the matter, and the reasons (which may be in the form of proposed findings) supporting an MPCA decision to hold a contested case hearing. Failure to comply with these rules exactly may result in a denial of the request. To the extent known, the petitioner may also submit a list of prospective witnesses to be called at a hearing, a proposed list of publications, references, or studies to be introduced at a hearing and the approximate time required for the petitioner to present the matter at a hearing. The decision whether to hold a contested case hearing will be made under Minn. R. 7000.1900.
