Public Notice of Intent to Issue 401 Water Quality Certification

The Minnesota Pollution Control Agency (MPCA) Commissioner has made a preliminary determination to certify the referenced project, with conditions, and has preliminarily determined that the project will satisfy the antidegradation standards in Minn. R. 7050.0265.

Major Watershed: Rainy River - Rainy Lake (#74)

Description of Issuance for 401 Water Quality Certification for City of Ranier Community Dock and Facilities Improvement Project #2024-00198-TMS.

The MPCA has examined the application and other information furnished by the applicant, the City of Ranier. The city proposes to construct a permanent dock structure to provide improved facilities for boaters. The applicant is proposing to replace and expand their existing boat dock in Rainy Lake. The dock would have a T-Shape design with eight floating fingers for additional docking. The primary walkway for the dock would be 20 feet wide and extend 266 feet [long] from the shoreline, into Rainy Lake. The T-section of the dock would be parallel to the shoreline and would be 15 feet wide by 199 feet long. The primary walkway would be supported by four square sheet pile cells and the T-section would be supported by one sheet pile cell all driven into bedrock. The proposed dock would have six 46-foot-long by six –foot-wide and two 28-foot-long by six-foot-wide floating docks connected to the main dock with gangways. After the new dock installation, the littoral drift would be improved and would restore the natural transport of sediments along the surrounding shoreline.

Procedure for public participation

As stated in Minn. R. chs. 7000 and 7001, there are three formal procedures for public participation in the MPCA's consideration of this matter. Interested persons may:

- (1) Submit written comments on the draft certification and antidegradation determination.
- (2) Petition the MPCA to hold a public informational meeting.
- (3) Petition the MPCA to hold a contested case hearing.

Submitting written comments

To submit comments or petitions to the MPCA through the mail or online you must state:

- (1) Your interest in the request for 401 water quality certification or the draft 401 water quality certification.
- (2) The action you wish the MPCA to take, including specific references to the section of the draft 401 water quality certification you believe should be changed.
- (3) The reasons supporting your position, stated with sufficient specificity as to allow the MPCA to investigate the merits of the position.

Public informational meeting

A public informational meeting is an informal meeting during which interested persons can ask questions concerning the proposed facility. MPCA staff will be present to provide information. If an interested person would like the MPCA to hold a public informational meeting, the person should include all information identified above and in addition include a statement of the reasons the person desires the MPCA to hold a public informational meeting and the issues that the person would like the agency to address at the public informational meeting.

Contested case hearing

A contested case hearing is a formal proceeding before an administrative law judge empowered to advise the MPCA regarding issues of fact. As described in Minn. R. 7000.1800, persons who submit petitions for a contested case hearing must also state the issues they propose to address in a contested case hearing, the specific relief requested or resolution of the matter, and the reasons (which may be in the form of proposed findings) supporting an MPCA decision to hold a contested case hearing. Failure to comply with these rules exactly may result in a denial of the request. To the extent known, the petitioner may also submit a list of prospective witnesses to be called at a hearing, a proposed list of publications, references, or studies to be introduced at a hearing and the approximate time required for the petitioner to present the matter at a hearing. The decision whether to hold a contested case hearing will be made under Minn. R. 7000.1900.
