Watershed: North Fork Crow River Receiving water: Rice Lake

Description of permitted activity

The facility will house 2,372 head of dairy in total confinement barns, partial confinement barns, open lots, and individual animal housing areas. Liquid manure generated by the animals will be stored within concrete and synthetic lined storage structures. Solid manure generated by the animals will be stockpiled with land application fields. Process wastewater and manure contaminated runoff from the facility will be stored within lined structures. Manure generated at the facility will be applied to surrounding cropland at agronomic rates. The final animal unit (AU) capacity of the facility will remain unchanged at 2,504.4 AU.

The preliminary determination to issue this Feedlots permit is tentative.

Submitted comments or petitions must state:

- 1) Your interest in the permit application or the draft permit.
- The action you wish the MPCA to take, including specific references to the section of the draft permit you believe should be changed.
- The reasons supporting your position, stated with sufficient specificity as to allow the MPCA to investigate the merits of the position.

Public informational meeting

A public informational meeting is an informal meeting during which interested persons can ask questions concerning the proposed facility. MPCA staff will be present to provide information. If an interested person would like the MPCA to hold a public informational meeting, the person should include all information identified above and in addition include a statement of the reasons the person desires the MPCA to hold a public informational meeting and the issues that the person would like the agency to address at the public informational meeting.

Contested Case Hearing

A contested case hearing is a formal proceeding before an administrative law judge empowered to advise the MPCA regarding issues of fact. As described in Minn. R. 7000.1800, persons who submit petitions for a contested case hearing must also state the issues they propose to address in a contested case hearing, the specific relief requested or resolution of the matter, and the reasons (which may be in the form of proposed findings) supporting an MPCA decision to hold a contested case hearing. Failure to comply with these rules exactly may result in a denial of the request. To the extent known, the petitioner may also submit a list of prospective witnesses to be called at a hearing, a proposed list of publications, references, or studies to be introduced at a hearing and the approximate time required for the petitioner to present the matter at a hearing. The decision whether to hold a contested case hearing will be made under Minn. R. 7000.1900.
