Thank you for the opportunity to comment on the U.S. Steel Keetac Mine and Tailings Basin permits and U.S. Steel's application for a variance. I would like to support the Minnesota Pollution Control Agency (MPCA) and strengthen enforcement of water quality standards that protect Minnesota wild rice, fish, and human health.

I believe the Minnesota Pollution Control Agency (MPCA) can and should strengthen the proposed Keetac permits because:

1. Compliance with sulfate standards is delayed unnecessarily.

The draft permits would not require Keetac to comply with Minnesota's sulfate standards until April 30, 2030. But from 2011 through 2016, MPCA already completed a full planning, study, and testing process for Keetac's sulfate reduction treatment. There's no reason to start over. In fact, the U.S. EPA told MPCA in September 2024 that further delay in compliance with the wild rice sulfate standard would not be appropriate.

2. Groundwater protections are missing.

State law requires groundwater protection, but the draft permits do not include it. There are no groundwater monitoring locations, and the permits don't disclose how much polluted wastewater is seeping into groundwater—especially from the tailings basin.

3. Aquatic life is left at risk.

The permits would allow Keetac to wait three years before even beginning to test whether its discharge is toxic to aquatic life—without any justification for the delay. Beyond that, biological assessments are only required "once every five years" and no start date is even specified. With no testing, there are no pollution limits for salts and ions that are known to kill sensitive aquatic species.

4. Mercury monitoring is incomplete.

The draft permits add mercury monitoring at discharge points but don't require monitoring in surface waters. Downstream waters are already impaired for mercury in fish. Sulfate pollution increases mercury release from sediments and its buildup in the food chain, yet this critical connection is not addressed.
