Re: Air Quality Construction Permit Application 10883 for Project Jupiter Power Plant by Yucca Growth Infrastructure, LLC.

Dear New Mexico Environment Department:

I am Lindsay Leveen of Sausalito, California. I am an award-winning journalist who exposed Bloom Energy of San Jose California for GREENWASHING. I am also an award-winning Chemical Engineer and who is considered by my peers to be one the world's leading experts on hydrogen, fuel cells and sustainable chemistry. I hold several patents in the are of clean energy and clean hydrogen.

I have reviewed Mr. Colin Cox's letter of July 6 to you on the matter of the 2,462 megawatts of Bloom fuel cells proposed for the data center in New Mexico, I agree 100% with the conclusions that Mr. Cox has drawn. The proposed project is a BLOOMDOGGLE !

I must add that I was the tipster to the US EPA on the Bloom desulfurization HAZMAT that resulted in the fine of \$1.37 million to Bloom. Bloom and Apple were also fined \$40,000 in North Carolina for mishandling HAZMAT at the Apple data center in Maiden, NC. Bloom has a long history of making FALSE clean energy claims and I convinced both NBC And Breitbart to report on Bloom's GREENWASHING. It is quite a miracle to get NBC and Breitbart to cover a story in the same way, but Bloom is so blatantly DIRTY that this happened.

The Bloom Executive (Marisa Blackshire), who submitted the permit application to you has LIED each and every month for the past six years to Delaware DNREC regarding Bloom's CO2 and NOX emissions. I have asked the California Bar Association to DISBAR Ms. Blackshire. Her LIES to DNREC have caused Delmarva Ratepayers in Delaware to be

overcharged more than \$100 MILLION in excess subsidies under the Qualified Fuel Cell Tariff in Delaware. I have provided the FBI and EPA CID recorded statements and volumes of irrefutable evidence that Bloom and their Tax Equity partner Southern Power have defrauded Delmarva ratepayers in Delaware.

I also managed to convince NYSERDA not to subsidize and further Bloom projects as the power Bloom generates is DIRTY and is unworthy of NYSERDA subsidies, I also convinced the California CPUC not to give Bloom any further subsidies under the SGIP Self Generation Incentive Program. Bloom depleted the SGIP by taking over \$200 million in subsidies that were not deserved.

Bloom has defrauded US Taxpayers and I have asked the IRS to investigate how Bloom took \$75 million for Investment Tax Credits in their replacement fuel cells in Delaware when the DE DNREC permit was for “minor maintenance” and not for full replacement of their first dilapidated power station at Red Lion and Brookside, DE. YES, Bloom let a power station that they told investors have a life of 22 years become so degraded in only six years that they needed complete replacement. You should note the \$10 billion Bloom project in New Mexico will mean that Bloom and their partners will take \$3 billion for TAXPAYERS for Investment Tax Credits.

The last thing New Mexico needs is Bloom Energy and for your state to become the site of a MASSIVE BLOOMDOGGLE. For God Sake don't approve their permit. Theranos was the Bloom of Blood and Bloom is the Theranos of Thermodynamics.
