You have heard these facts before - for the reason they are overwhelming evidence for denying Project Jupiter. We are in the beginnings of an intense climate change and need to preserve our resources to the max as we head into diminished water supplies, intense heat build up along with more massive wildfires, and huge storms with flooding. We not only need to conserve but use our resources to develop clean energy to cut greenhouse gases. The time is now.

Project Jupiter's power plant will release up to 10 million tons of climate-warming greenhouse gasses every year. This would make a mockery of NM's climate goals, and erase most of the climate progress we have made in the last two decades.

This is more greenhouse gas pollution than New Mexico's three largest cities combined – Albuquerque, Las Cruces, and Santa Fe.

The proposed "micro" grid has a 2,462 MW Capacity. For comparison, the El Paso Electric grid is about 2,900 megawatts (which services NM's second largest city, Las Cruces) and the entire PNM grid is about 2,700 megawatts. Each of those grids include a substantial amount of renewable energy sources and each of those grids has lower total greenhouse gas pollution than just Project Jupiter's proposed power plant.

ENVIRONMENTAL JUSTICE

Santa Teresa Elementary and High School are located within five miles of this project site. 96% of students at the high school are hispanic. There are also day care centers located within miles of this site. This is an environmental injustice to these children who are especially vulnerable to the health impacts of NOX, CO, and VOCs.

The Chihuahuan Desert borderlands are not a barren dump site for Bloom Technologies to test their experimental technologies. Santa Teresa should not serve as ground zero for Bloom Technologies to scale their toxic technologies.

Tribal governments like Tortugas Pueblo, Ysleta del Sur, and Pueblo communities with landholdings in Doña Ana county near the site have not been properly notified of this air permit application request.

FUEL CELL TECHNOLOGY IS UNCERTAIN

Fuel cell technology has not been deployed at this scale. This is 60 times larger than the largest existing Bloom fuel cell installation.

The Application is based on pollution testing from a very small unit. The testing unit is only 65kw, while the power plant is 37,876 times that size.

TOXIC WASTE

Fuel cells generate hazardous waste. Fuel cells filter out sulfur and other contaminants in the methane stream. These contaminants accumulate as hazardous waste in "desulf canisters." The power plant will be generating enormous amounts of hazardous waste. Jupiter claims that any pollution from opening and changing the filter media in the desulf canisters is exempt from air permitting regulations (because there is less than 1000 lbs/yr).

Bloom was fined for improper hazardous waste handling in Pennsylvania and Maryland. In 2020, Bloom was fined \$210,000, and then \$1,161,000.

GOVERNANCE

NMED's mission is "to protect and restore the environment and to foster a healthy and prosperous New Mexico for present and future generations." Granting these permit applications is a direct

contradiction to that mission.

What happened to the public hearing the state Air Quality Bureau recommended on the previous applications that the industry has since redacted? NMED should not overlook the overwhelming community concern expressed in the last public comment period, which still applies to this same project.

CALLS TO ACTION FOR YOUR COMMENT:

I urge the NMED to reject YUCCA Yucca Growth Infrastructure, LLC's air permit application for the YGI Microgrid.

If NMED does not reject the permit, I ask the department to please hold a bilingual hybrid public hearing near the Santa Teresa community, so that residents can learn about the risks associated with fuel cell technology.

NMED should give the public 60 days of additional time to review and comment on the application to ensure everyone can meaningfully comment and participate.
