Specifically, we support the following elements of the draft Strategic Plan:

Goal 1.1: Develop partnerships and collaborations for implementing sustainable pest management

We see this as an important means by which DPR can implement its core values of accountability and collaboration. To that end, we encourage DPR to include representation of drinking water agencies within the planned SPM advisory group.

Goal 1.2: Improve timeliness and transparency of science-based evaluation and registration of pesticide products

We appreciate DPR's recent efforts and initiatives in this area, particularly regarding the goal to upgrade the process for pesticide registration environmental review.

Goal 1.3: Develop and implement a prioritization process for reviewing, identifying and evaluating high-risk pesticides, and alternatives and mitigating measures for those high-risk pesticides

We request that specific consideration of potential human health impacts via the drinking water exposure route be included in the development and implementation of the prioritization process, and again request that drinking water agency representation be included in the planned SPM advisory group.

Goal 2.1: Enhance and modernize DPR's collection of information and data to improve program policies, procedures, and priorities

We appreciate DPR's initiatives in this area, and request inclusion of monitoring parameters related to potential drinking water concerns in relation to the goal to establish ongoing ecosystem monitoring. This would include TOC and DOC in addition to pesticides of potential human health concern in drinking water source waters.

Goal 3.2: Improve information access and data sharing

We support the specific goals listed under this topic, as these steps will all contribute to the Department's accountability, collaboration, and transparency.
