Our family has to refrain from taking walks along the Salsipuedes Creek near our house because we know that pesticides are being used, but are not informed about when and where. Last year we signed up for a notification program that informed us when fumigation applications were being made, but did not tell us where. This year we have been receiving no notification at all.

We strongly support the effort to provide Californians with advance notice of hazardous pesticide use. We urge you to make sure the new regulation is as effective as possible to ensure that impacted residents can protect themselves from harm. To truly be effective, the system must include the exact location of planned pesticide applications.

Scientific research confirms that the public is in greater risk of harm the closer they are to a pesticide application. An application next to one's house is of even greater concern than an application a mile away and would require more precautions.
