Public notice is hereby given that the Ohio Environmental Protection Agency (Ohio EPA) Division of Surface Water (DSW) has received an application for, and has begun to consider whether to issue or deny, a Clean Water Act Section 401 water quality certification for a project to rehabilitate the Brent Spence Bridge carrying I-71 and I-75 over the Ohio River, construct an additional companion bridge to carry express lanes of the same, and realign I71 and I75 to account for the new bridge. The application was submitted by Ohio Department of Transportation. The project is located at Interstate 71/75, Cincinnati, OH, 45203. The Huntington District Corps of Engineers Public Notice Number for this project is LRH-2006-02138-OHR. The Ohio EPA ID Number for this project is 249797A. Discharges from the activity, if approved, would result in degradation to, or lowering of, the water quality of the Ohio River.
